July 2022 Board Meeting Highlights



Monthly Reports:

Operations reported that crews are doing routine maintenance, pole replacements, and regular summer construction. We have a total of 49 new services plowed in to-date. The new

summer help worker started. The co-op is currently working with Dairyland Power Cooperative and Power Systems Engineering regarding a new substation.

The Director of IT reported that the Office 365 conversion is complete, and we are looking to expand our use of the suite of products. Other updates reported on were that work to the server room is complete, implementation of tracking member contacts is in progress, and in the near future a process/procedure will be worked on for allowing members to text in their outages.

The CFO reported that financially June came in a bit below budget. However, year-to-date the cooperative is about 3.5% ahead of budget in terms of kilowatt hour sales and revenue. It was also reported that the review of employee policies is underway.

The CEO/General Manager gave an overview on day-to-day operations. It was also reported that

the State of Wisconsin released the Wis. Electric Vehicle Infrastructure plan, which provides federal funds to install EV fast chargers. Only certain thoroughfares qualify and one location is on the DEC system. It was also noted that the co-op was given an award for no lost time due to injury or accident. He also discussed several upcoming meeting and educational opportunities for the board to attend.

The following items were approved:

- Minutes of the June 2022 Board meeting
- Capital credit estate payout for deceased members.
- Audit committee report of all checks, ACH payments, wire transfers, credit card statements, and investments accounts.

Director Zwiefelhofer reported on Dairyland Power activities for the month.
