

BILLING DUE DATE TO CHANGE


In August, the United States Postal Service (USPS) announced their finalized plan to slow mail delivery service starting October 1, 2021. With this information in mind, **Dunn Energy Cooperative has made the decision to change the billing due date from the 15th of the month, to the 20th of the month.** This will go into effect with the bill you

This will go into effect with the bill receive in November.

However, just because we are changing the due date doesn't mean we want you to change when you mail your payment. These five extra days are to help lessen the occurrence of accidental late fees charged to accounts. According to the USPS, the agency is changing its standard time frame for delivering first-class letters, flat envelopes, and periodicals. The benchmark will go from a one-to-three-day delivery window to a one-to-five-day delivery window. So, if there are an additional one to two days for us to get the bill to you, and then another additional one to two days for you to get your payment mailed to us, that eats up the extra five days we are adding on before the bill is due.

The people who will see the greatest impact of this change are those members who are on auto-pay. Bills will be drafted on the 20th of each month instead of the 15th of the month starting with the bill you receive at the beginning of November.

If you would like to get your bill sooner, and be able to pay it without worrying about stamps, you can always use SmartHub, our online account management program. It's convenient and free to use. All you need to know to sign up is your last name, account number, and billing zip code. You can find SmartHub on our website at dunnenergy.com or through your app store on your phone or tablet.

Monthly Reports:

Operations reported that 79 new services have been installed this year. Tjader & Highstrom is working on three work plan projects near the

Colfax area. Herbicide application has been completed in Lucas and will start soon in Downsville. Brushing continues in parts of the Downsville area and we will be moving to the Tainter area next.

Energy Services reported on the long lead times to get new meters which are now at 6-12 months. He also discussed load management controls as well as renewable energy. There are only 30 shares remaining in our SunDEC Community Solar array. Maintenance to the building was reviewed. Renewable energy policies and excess generation purchases from members was also talked about.

July financials showed energy sales volume 2.3% over budget due to warmer temperatures. Year-to-date operating revenues are about 1.3% above budget with expenses slightly over-budget due to the increased demand and power cost this summer. This results in year-to-date local operating margins 1.12% above budget.

The CEO/General Manager shared that Dunn Energy scored an 85 on a recent national customer satisfaction

survey. Nationwide, cooperatives averaged a score of 74 and investor-owned utilities averaged a 72. The Board commended the staff on achieving one of the highest scores in the nation for member satisfaction. Also, the Level 3 electric vehicle charger is up and running at the 29 Pines Travel Plaza on County Highway T in Chippewa County. Future renewable energy options for the Cooperative were also talked about.
