#### **LOAD CONTROL TEST SET FOR NOV 20**

Please be advised the Winter Test for Interruptible Heat (Dual Fuel) members is scheduled for Wednesday, November 20. This date is the Wednesday of the week before Thanksgiving, the same test day as prior years. This load control test is performed in advance of the winter Full Load Control season to ensure member familiarity with the control sequence and to ensure that backup heating systems have been validated for proper function.

Residential Interruptible Heat load classes will be controlled as follows:

**Control Start:** All Interruptible Heat load classes will begin control at 6:55 a.m. without pre-alert.

**Restoral:** All Interruptible Heat loads will vary in restoral, beginning at 10:30 a.m. with full restoral at 11 a.m.



# CALLING ALL INTERESTED PARTIES FOR DIRECTOR IN DISTRICTS 2, 3, AND 5!

n the world of not-forprofit organizations, member-owned cooperative businesses included, the board of directors sets the direction of the business. They're the ones who make decisions on rate schedules, annual budgets, special contracts, and more. All of these decisions are made with the guidance of the cooperative leadership team, but ultimately the decision is made by nine members who live and work in our communities. This year, two of our long-serving directors will not be returning to the board room as they have served their full 12 years and are not eligible for reelection. This means we are looking for four

qualified individuals to run for those seats in districts 2 and 5. District 3 director, Jeff Gasteyer, is up for reelection.

The directors have a huge responsibility to the members the cooperative serves. In order to make informed decisions in board meetings, the directors are expected to complete the Credentialed Cooperative Director certification within their first three-year term. The course consists of five full day classes. On top of this, directors have the opportunity to attend many other educational opportunities throughout the year, ranging from energy issues summits and regional trade meetings to our national lobby days.

Do you have the time and interest in serving on your cooperative board of directors? Would you like to help set the direction of the cooperative in coming years? Are you committed to the communities we serve? If so, please watch your mailbox in December for information on the next director elections. The district notification letter will be sent to members whose districts are up for election. Once that letter comes out, getting on the ballot is simple. Just notify your member of the Nominations Committee of your interest in running. Their information will be listed in the district notification letter. They will provide you with a director's job description and an application to fill out. You'll be directed to return the application to either your committee member or the cooperative office. Your committee member will bring your name to the first Nomination Committee meeting. The committee then votes on who to add to the ballots for the annual meeting.

Each year at the annual meeting, three of the nine directors are elected to serve a three-year term on the board of directors. The 2025 Annual Meeting will be held on Thursday, May 15, 2025. If running for director is something that interests you, please consider this your formal invitation to make a difference.

# DIRECTOR DUTIES & RESPONSIBILITIES

All you need to know

#### Who is on the board?

The board of directors is made up of nine cooperative members: one from each of the nine cooperative districts.

#### What does a director do?

A director represents all members of Dunn Energy Cooperative and is responsible for approving general policies, annual budgets, special contracts, capital credit retirements, bylaw amendment changes, rate schedules, and delegating authority to the General Manager to execute and carry out the daily activities of the Cooperative.

#### When does the board meet?

The board of directors meets the last Monday of each month with meetings beginning at 9 a.m. and regularly lasting until Noon.

#### Is there any compensation?

Directors are paid a per diem for each meeting attended as well as IRS approved mileage.

### What is the time committment?

From monthly board meetings, DECs Annual Meeting, trainings, member events, to workshops and travel, the typical time commitment for board members is approximately 24-30 days/evenings per year.

## **COMMITMENT TO COMMUNITY, NEAR AND FAR**

ctober was National Co-op Month. It's our month to spotlight all of the great things that cooperatives stand for. This year was extra special, however. We kicked off Co-op Month with a Day of Service that benefitted the Beaver Creek Reserve. A handful of Dunn Energy employees partnered with Eau Claire Energy Cooperative and Dairyland Power for a full day of service. Trees were cut, brush removed, picnic tables painted, and more. The impact of the day was tens of

thousands of dollars' worth of time and materials for a non-profit organization.

Even more incredible was the fact that two of our linemen, Pat Rhude and Landan Romsos, volunteered to go to Aiken Electric Cooperative in South Carolina for up to two weeks to help with rebuilding and restoration of the electric infrastructure in the aftermath of Hurricane Helene.

As a part of a convoy of 45 linemen and mechanics from 15 Wisconsin electric cooperatives, Pat and Landan headed south on October 2. The destruction was widespread. At one point Georgia co-ops had about 191,000 outstanding outages, with 144,473 in South Carolina and a little more than 100,000 in North Carolina.

"In parts of South Carolina, where our Wisconsin crews

are heading, it's not just a restoration, but a complete rebuild," said Rob Richard, Wisconsin Electric Cooperative Association (WECA) interim president and CEO. "Full substations, and the roads that lead to them, are completely washed away. Even the underground lines are gone. Our thoughts and prayers go out to all who are impacted."

This is what being a cooperative is about—being committed to something bigger than yourself and helping those in need. We're proud of our employees and their service to others.
