



BECOMING MORE EFFICIENT ONE MEMBER AT A TIME

ay in and day out, our staff works to safely provide our members with reliable, affordable, and environmentally responsible energy. Since we are a cooperative, we have to work together, both staff and members, to help make Dunn Energy stronger and more efficient. There are several things a member can do to help the cooperative achieve those goals.

Members can take advantage of billing solutions to make the process of receiving and paying energy bills simple. Visit dunnenergy.com to create a SmartHub account. You'll be able to view your usage history, report outages, and contact certain departments at the cooperative directly. You can also activate the e-bill feature in SmartHub, having

your bill delivered to your inbox as soon as it is available, instead of waiting for the mail. You'll help save the cooperative and yourself money by lowering printing and postage costs.

You can take it one step further and set your account up for recurring payment using a credit/debit card or via ACH directly out of your savings/ checking account. The payment is drafted on the 20th of each month (or the first business day after the 20th if it falls on a weekend or holiday) and helps save cooperative staff time by not having to process those payments manually each month.

As an end-user, you can also help the cooperative be more efficient

by paying attention to when you use energy. If you can shift your large appliance usage to outside the hours of 5-8 p.m., that helps balance load. Even if you unstack your usage (e.g., don't run everything at the same time), that helps reduce demand on the energy grid. However, if you don't want to think about it, you can have the co-op do it for you through an energy management program. (962001)

If you have a central air conditioner, a Dunn Energy technician can install a device that allows the cooperative to occasionally cycle your air conditioner (15 minutes on and 15 minutes off) during times when the cooperative needs to manage energy on the grid. Several hundred members are already saving up to \$24 per year by

AMID STORMS, DUNN ENERGY COOPERATIVE HOLDS 88TH ANNUAL MEETING OF MEMBERS

Tornado watches and warnings. Weather radio and cell phone alerts. Despite the hazardous weather, 109 members attended the annual meeting on Thursday, May 15, including special guests Rob Richard, president & CEO of the Wisconsin Energy Cooperative Association, State Representative Rob Kreibich, and guest speaker Adam Accola of the newly formed Dunn Economic Development group.

Board President Jeff Gasteyer led the meeting. In his speech he spoke about general cooperative facts, the challenges the cooperative faced in 2024, and community support.

Gasteyer spoke about the over \$25,000 in Operation Round Up grants that were given out in 2024. These grants were made possible by members who round their bills up to the nearest dollar. Grants were awarded to local, notfor-profit organizations including The Wisconsin Foster Closet, Food Harvest Ministry, and the Durand Women's Club. These organizations provided necessary school supplies and food donations to those in need in our area.

In closing, he spoke about the future of Dunn Energy Cooperative. "The energy industry is changing rapidly,

from AI technology, data centers, and changing government regulations, to new carbon-free sources of generation," said Gasteyer. "I assure you Dunn Energy will be ready as we navigate the ever-changing landscape."

General Manager and CEO, Jesse Singerhouse, spent time with the membership talking about the Cooperative's extensive safety program and the importance of the daily effort by employees. "Recently our team hit a milestone of driving over 2 million miles without an accident. That is an incredible achievement and I'm very proud of the safety culture we have here at Dunn Energy," said Singerhouse.

He also recognized this year's 20 recipients of \$1,000 scholarships and the several employees who reached milestones in 2024: Landan Romsos (10 years), Tyrel Blanchfield (15 years),

Other recognition was given to the two directors retiring from the board after fulfilling their maximum of 12 years of service to the cooperative. Brian Johnson and Ed Hartung were thanked for their service and given a meter lamp as a token of the cooperative's appreciation.

Operationally, Singerhouse went over the cooperative's 2024 financials, as well as some interesting figures relative to Dunn Energy. This included noting that by having 232 irrigation accounts, Dunn Energy is one of the largest Wisconsin cooperatives in regard to irrigation load.

Guest speaker Adam Accola spoke

about the importance of economic development in rural areas. His organization is working on the issues of housing, business retention and expansion, and business attraction. He noted that 80% of new jobs and capital investment come from companies that already exist in the greater Menomonie area, and his number one goal is to provide assistance with issues that could force a company to close or relocate to a new community.

The business meeting ended with the election of directors. Two new directors, Patrick Lindgren in District 2 and Diane Traxler Fredrick in District 5, joined incumbent Jeff Gasteyer as the ticket winners in Thursday night's election.

Singerhouse ended his remarks to

members, talking about the cooperative business model. "The cooperative business model is very near and dear to my heart," said Singerhouse. "Because it is people working together to serve a purpose. That is a powerful thing and something we can use in all aspects of our life."

Despite the challenges of 2024, and the hours leading up to the meeting, it was evident the cooperative spirit is alive and well. Members showed up to support their cooperative and a successful meeting was held.
